Admission Policy of Gunma University Graduate School

Admission policy

We accept students who have the academic ability and research skills required by each graduate school and by major, and who have research motivation to contribute to the development of human society through research and practical ability.

Admission Policy of Gunma University The Graduate School of Health Sciences (Master's Program)

— Our Master's Program is recruiting for the following applicants. —

<Human resource development goals>

1. To understand holistic medical health care and to acquire advanced specialized skills and expertise.
2. To acquire basic skills to put into practice education and research in the specialized fields.
3. To be able to practice activities as healthcare or welfare professionals in the local community.
4. To be able to practice activities in the international fields of healthcare or welfare.

<Abilities and Qualities Required of Applicants>

1. Those who have knowledge and skills at the Bachelor's level required for the Master's course.
2. Those who have logical thinking skills, communication skills, and language proficiency necessary for research activities.
3. Those who wish to make social contributions as highly skilled professionals in the the fields of health, medical care and welfare.
4. Those who wish to enter the Doctoral program in health sciences after completing the Master's Program and become researchers, educators, or highly skilled professionals in health sciences.

<Basic policy for admissions>

The School conducts the following entrance examination to select students with the above qualities, and judgments are made based on the results of an essay, an academic achievement test in a foreign language, and an oral examination, as well as the applicant's submitted application documents, including transcripts and an outline of desired research.

○General entrance examination and entrance examination for working adults

An academic achievement test (essay and foreign language) is used to evaluate "knowledge and thinking skills in healthcare and medical care in general" and "English language skills in understanding English research literature" (Abilities and Qualities Required of Applicants 1 and 2). An oral examination is also used to evaluate "expertise, research skills and research plans, as well as aptitude and motivation as a researcher or a highly skilled professional" (Abilities and Qualities Required of Applicants 1-4). In addition, application documents will be added to the overall evaluation.

○International student entrance examination

A test of foreign language proficiency (English) is used to evaluate "competence in understanding English research literature" (Abilities and Qualities Required of Applicants 2). An oral examination is also used to evaluate "expertise, research skills and research plans, as well as aptitude and motivation as a researcher or a highly skilled professional" (Abilities and Qualities Required of Applicants 1-4). In addition, application documents will be added to the overall evaluation.

- (Note 1) If the number of students completed entrance procedures is less than the number of students admitted with a recommendation-based entrance exam, the number of students recruited will be raised as a general rule.

2 Application eligibility

(1) General entrance examination

Applicants need to fall under any of the following provisions.

- 1) A person who has graduated or is expected to graduate from a university by March 2027.
- 2) A person who has been conferred or is expected to be conferred a bachelor's degree by March 2027 under the provisions of Article No. 104-7 of the School Education Act (Act No. 26 of 1947).
- 3) A person who has completed or is expected to complete a 16-year course of school education in a foreign country by March 2027.
- 4) A person who has completed or is expected to complete a 16-year course of foreign school education by taking class subjects in Japan through correspondence courses run by the foreign country concerned by March 2027.
- 5) A person who has completed or is expected to complete a foreign country's university course at an educational institution in Japan (limited to the person who has completed a 16-year course of the said foreign school education) which is designated as having a foreign university's curriculum in the said foreign country's education system and separately designated by the Minister of Education, Culture, Sports, Science and Technology by March 2027.
- 6) A person who has completed three or more years of study at a foreign university, or at a foreign educational institution (including a person who, while residing in Japan, has completed the program of education provided by a foreign university or foreign educational institution through correspondence or distance education courses), and who received or is expected to be conferred a degree certificate by March 2027 that is recognized by the Japanese Ministry of Education, Culture, Sports, Science and Technology.
- 7) A person who has completed or is expected to complete a specialized course separately designated by the Minister of Education, Culture, Sports, Science and Technology at a vocational school on or after the date specified by the Minister of Education, Culture, Sports, Science and Technology (limited to a vocational school with a school term of four years or more that meets the other standards specified by the Minister of Education, Culture, Sports, Science and Technology), or to be awarded by March 2027.
- 8) A person designated by the Minister of Education, Culture, Sports, Science and Technology

(Notification No.5 of the Ministry of Education, 1953).

- 9) A person who entered a graduate school other than our Graduate School based on the provisions of Article 102-2 of the School Education Act (Act No. 26 of 1947) and who has been recognized by our Graduate School as having academic abilities appropriate for receiving graduate school education.
- 10) A person who has been recognized by our Graduate School as having academic abilities equivalent or superior to those of a person who has graduated from a university based on the results of the individual examination of the applicant's qualifications, and who will be 22 years of age by March 31, 2027.
- 11) A person who has been enrolled in a university for 3 years or more by March 2027 (including an equivalent person specified by the Minister of Education, Culture, Sports and Technology), and who has been recognized by Gunma University as having acquired the required units with excellent results.

(2) Entrance examination for working people

Applicants who fall under any of provisions for General entrance examination listed above and meet the following conditions ① and ②, and also satisfies the ③ or ④ below.

- ① A person who reach the age of 22 by March 31, 2027.
- ② A person who have work experience of a total of at least one year or more.
- ③ A person with a job and continues to work on and after April 1, 2027.
- ④ A person who will have a job on and after April 1, 2027.

(3) Entrance examination for international students

Foreign people without Japanese citizenship are permitted to apply for the entrance examination when they have or are expected to have a status of residence which is not interfering with university admission, and have not obtained permanent residency in Japan and fall under any one of the application eligibilities for general entrance examination.

3 Screening of application eligibility

- (1) A person who intends to apply under the provisions of the applicant eligibility 9) and 10) must satisfy the screening requirements for admission to our Graduate School before applying under the following conditions, while only those who have proven to have met the Qualifications for Application can apply.

In the screening, we will focus on evaluating whether the applicant has the basic academic ability to receive education in the preferred unit or specialized research field and whether he/she has academic ability equivalent or superior to that of a university graduate. We will make a comprehensive judgment on each applicant based on his/her conference presentations and paper presentations as the first author in the health, medical, and welfare fields, or having the qualifications recognized by various occupational fields and academic societies. If necessary, an interview will also be conducted.

The result of the qualification screening will be notified to each applicant by July 22(Wed.), 2026.

A. Deadline for application

Due not later than July 1 (Wed.), 2026.

B. Application documents

- I Application for the screening of admission requirements (The form attached to our admission guidelines must be used. [Form-7-1]) In addition, Form 7-2 must be submitted.

- III Certificate of student status (issued by the president of the university (graduate school) you are enrolled in along with the date of your entrance). If you completed or quit the graduate school, submit the document with the date of your entrance (e.g. the transcript from the graduate school).
- IV Research achievements or other significant achievements, if any. (theses, conference abstracts, etc.)
- V Other documents.

② In the case of the screening concerning Qualifications for Application (10):

- I Application for the screening of admission requirements (The form attached to our admission guidelines must be used. [Form-7-1]) In addition, Form 7-2 must be submitted.
- II Report on Research or work, etc. (The form attached to our admission guidelines must be used. [Form-8])
- III Research achievements or other significant achievements, if any. (theses, conference abstracts, etc.)
- IV Graduation Certificate or Completion Certificate issued by the final educational institution (including a junior college, an advanced vocational school, or a vocational school, etc.) from which the applicant graduated.
- V Academic transcript issued by the final educational institution (including a junior college, an advanced vocational school, or a vocational school, etc.) from which the applicant graduated.
- VI Other documents.

(2) A person who intends to apply under the provisions of Qualifications for Application (11) must inquire at the office described in (1)-C before applying.

4 Application period

Application documents must arrive during the period from July 24 (Fri.), 2026 to 5:00 p.m. (Japan time) July 30, (Thu.), 2026 by mail.

Bringing application documents in person or by proxy is not acceptable.

(Note) No application documents are accepted after the application period. Applicants need to send the application documents with full liability of the necessary days for mail delivery.

9 The aim of each examination subject

EssayThe examination measures your general knowledge about health science and medical science.

Foreign language (English).....The examination measures your reading comprehension of the English literature.

Oral examinationThe oral examination asks specialized knowledge, research capability and study plan of each applicant individually to evaluate the adequacy and motivation as researcher or professional with a high level of expertise.

(1) **General entrance examination and Examination for working people**

Foreign language (English) examination

- ① A written test of foreign language (English) can be substituted by submitting any official score of TOEFL iBT (internet-based test), TOEFL iBT Home Edition, TOEIC Listening & Reading Test (open test) issued by ETS, or IELTS (Academic module).

Applicants who have submitted any one of TOEFL's official score report, score card, official certificate of TOEIC Listening & Reading Test (open test or IELTS (Academic module)) at the time of application can take the foreign language (English) test also, if they wish. In that case, the better result will be used for evaluation.

You need to submit the original of the score report, score card, or official certificate. The copy is not acceptable. The original shall be returned with the examination admission ticket. If you are using the official TOEIC or TOEFL Digital Certificate issued by ETS, please print and submit a hard copy (printout) of the certificate. The QR code on the digital certificate must be valid. Please note that submitted documents will not be returned.

16 Special measures for educational method

We offer the day and evening courses system for students who have passed the entrance examination for working people, and those in employment who have passed the general entrance examination, if they wish.

Under the system, education is provided at night (from 6:00 p.m. to 9:10 p.m.), on Saturdays, Sundays and national holidays and during summer or other vacation period.

17 System for long-term degree completion

The system allows particular students such as students in employment who have difficulty completing the regular course within the formally-stated period of study (2 years for master's course) to extend the study period so that they can take and complete the courses systematically over the said period.

Students who would like to use the system need to consult with the supervisor and apply within the application period.

(1) Eligible students

- 1) Students in employment (or to be employed) who have difficulty sparing time to study or to take lessons due to business assignment,
- 2) Students who have difficulty sparing time to study or to take lessons due to household duties, childcare and/or nursing care,
- 3) Besides these, students who have reasons the Graduate School of Health Sciences approves for application of the said system.

(2) Long-term study period

The period adding one year or two years to the formally-stated period of study (but the school days should not exceed twice as long as the said period of study).

The annual tuition fee for the long-term study period is the amount obtained by multiplying the number of years equivalent to the number of the formally-stated period of study (two years) to the prescribed annual tuition fee (JPY 535,800) and then being divided by the number of course term given for a long-term student.

2 Course for Certified Nurse Specialist (CNS)

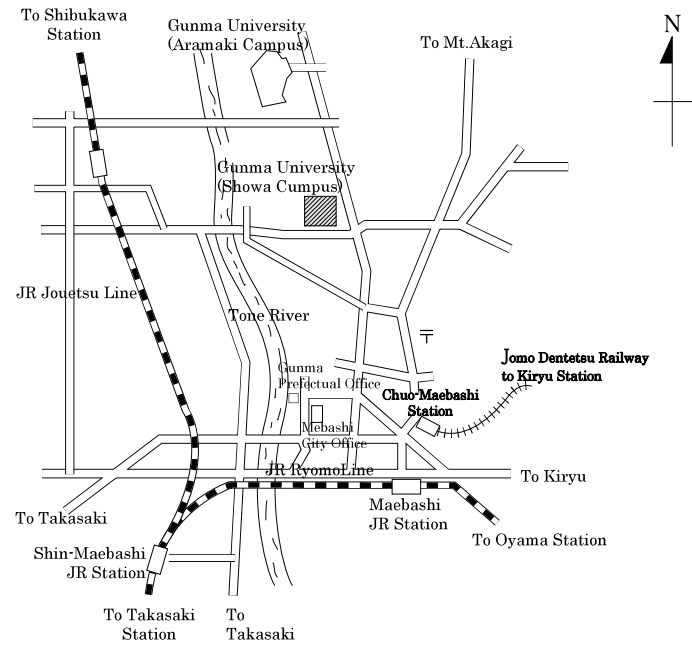

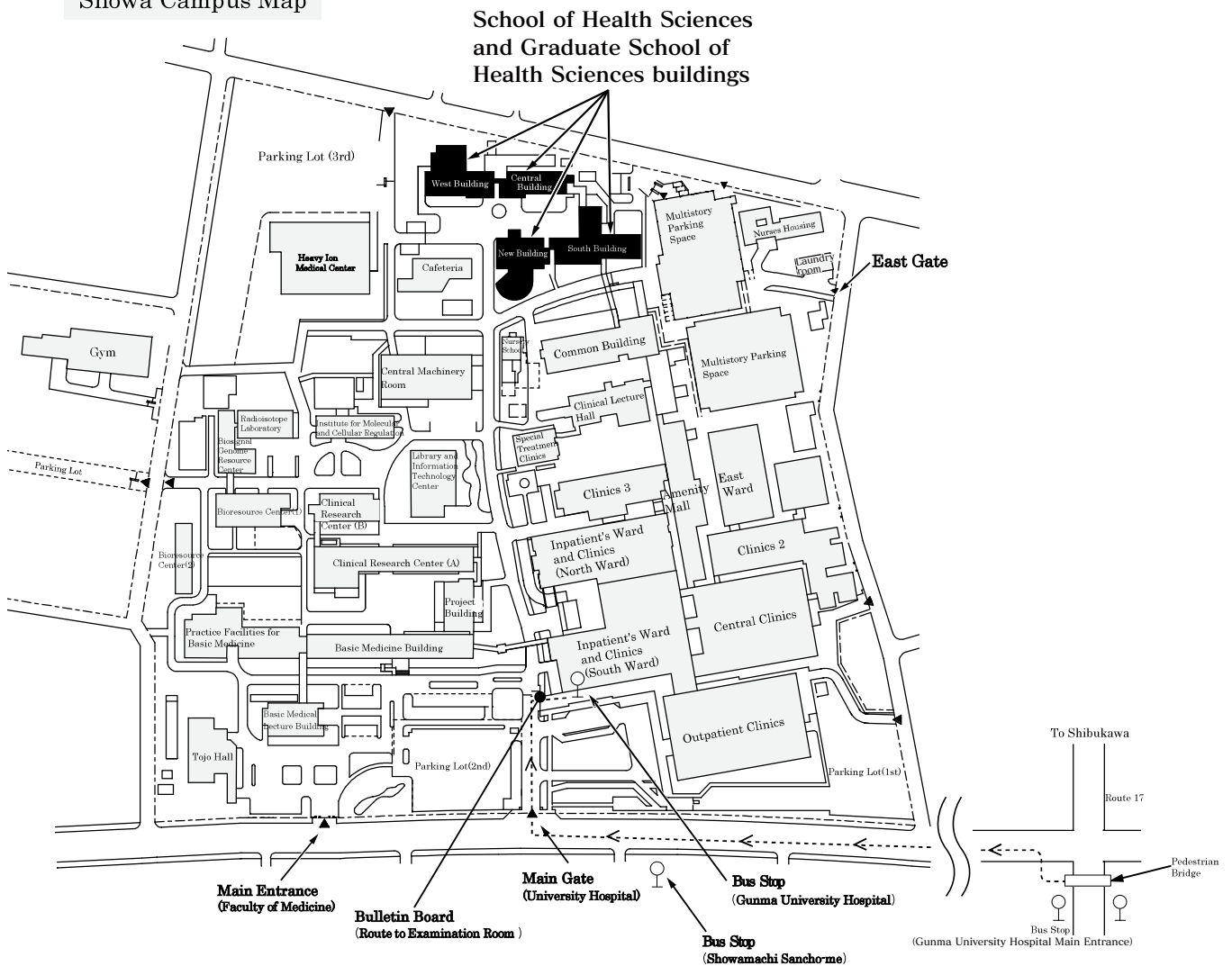

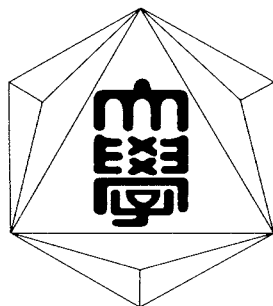
